15-YEAR LIMITED WARRANTY

WARRANTY INFORMATION

This warranty information sets forth the details about our warranty for **Shower Door Hardware** (“the Products”) as well as information about the rights, obligations, limitations, and exclusions that apply to the Products manufactured, distributed and sold by Frameless Hardware Company (“FHC”). All of FHC’s Products are warranted to be free from defects in workmanship and materials for the time period defined herein. This warranty is extended only to FHC’s distributors of our Products and the first user who purchases Products for purposes other than resale (“Buyer”). It is the Buyer’s responsibility to determine the suitability of the FHC Products for each intended use. A Buyer assumes all risks and liability in connection with the installation, use, or inability to use the Products as recommended by FHC. In addition, Buyer agrees to accept possession of purchased Products with the understating that FHC’s liability does not exceed the stated invoice price of the Products shipped and received by Buyer. Any representations, warranties or promises inconsistent with, or in addition to, the warranties contained herein are unauthorized and shall not be binding upon FHC. No salesperson, agent, employee or representative of FHC has any authority to extend or change the terms of this warranty. All warranty claims are subject to physical inspection by FHC prior to FHC providing a resolution for the warranty claim including an evaluation by FHC that the Products were properly installed and maintained in compliance with FHC published guidelines.

Frameless Hardware Company (FHC) warrants its Products for a period of **fifteen (15) years** following the invoice date for Products purchased by Buyer, FHC’s Products are warranted for material defects and/or defects in workmanship.

If FHC determines that this Warranty applies, FHC’s sole obligation shall be limited to either refund the purchase price to the buyer of Products, or FHC may provide a replacement of the Products purchased within the warranty period. A refund or replacement shall constitute the limit of FHC’s liability and obligation for any material defect or defect in workmanship in the alleged defective Products. No other remedies are available to a buyer.

FHC is not responsible for any other type of warranty, express or implied, including without limitation, any implied warranty of merchantability of the Products fitness for a particular purpose. In no event shall FHC be liable under any other legal basis (including but not limited to contract, negligence, strict liability in tort, or warranty of any kind) for any indirect, special, incidental, consequential, or exemplary damages (including but not limited to lost profits) allegedly suffered by a buyer.

Because FHC has no control over the conditions under which the Products are used, FHC specifically does not warranty the adequacy or sufficiency of any advice or recommendations given to Buyer by third parties including parties providing installation of Products. FHC shall not be bound by terms of any agreements between a Buyer and such third parties.
